Summary.

- Operating performance improves in the first half of the year.
- Guidance revised to reflect significant deterioration in business conditions. BMW Group expects a pre-tax return on sales on a Group level of at least 4%.
- Group revenues first half 2008: euro 27,837 million (+4.5%).
- Group profit before tax in the first six months: euro 1,243 million (-35.2%).
- Automobiles profit before tax in the first six months: euro 864 million (-38.7%).
