Milan Nedeljković as the new Chairman of the Board of Management. Dr.-Ing. Milan Nedeljković has worked for the BMW Group since 1993 and has been Member of the Board of Management responsible for Production since 1 October 2019. The current Chairman of the Board of Management, Oliver Zipse, will - by mutual agreement with the Supervisory Board - resign as Chairman and Member of the Board of Management at the end of 13 May 2026, the day planned for the 2026 Annual General Meeting. His term of office was last extended in 2023 until 2026.
