**Announcement pursuant to art. 5 para. 1 lit. b) of Regulation (EU) no 596/2014 and art. 2 para. 3 of Delegated Regulation (EU) no 2016/1052**

In the period from 31 March 2025 through 6 April 2025, Bayerische Motoren Werke Aktiengesellschaft (BMW AG) acquired a total of 629,518 ordinary shares and 153,363 preferred shares as part of its share buy-back programme 2023/2025.

The fourth tranche of the share buy-back programme 2023/2025 was completed on 3 April 2025. This tranche concludes the share buy-back programme 2023/2025. As part of this fourth tranche, a total of 5,297,129 ordinary shares and 1,151,759 preferred shares were acquired between 2 January 2025 and 3 April 2025. Together with the first three tranches of the share buy-back programme 2023/2025, a total of 18,660,741 ordinary and 4,244,903 preferred shares were purchased.

A total purchase price (excluding ancillary costs) of EUR 499,999,978.80 was paid for the shares purchased as part of the fourth tranche. For the share buy-back programme 2023/2025, the total purchase price (excluding ancillary costs) is therefore EUR 1,999,998,680.97. The average purchase price paid for the shares purchased in the share buy-back programme 2023/2025 was EUR 88.42 per ordinary share and EUR 82.45 per preferred share.
